#### Election Runner:

- Trial was completed by the governance committee members
- Cost in the past we've had ~300 votes, so expected cost could be ~\$50-75 based on fee structure
  - We need to clarify if we are charged for all the uploaded eligible voters or for the number of actual votes submitted. If charged for all eligible voters the expected cost could be ~\$450.



- Benefit it's secured, we as HCPA or governance committee are not controlling the process just monitoring the process, it's used by other charters, reminder emails to those who hadn't voted yet without bothering those who already did, can see if someone voted, can't see who they voted for, creates nice report that we could present to the board when tallying the results
- Upload email addresses for each voter, which generates unique voter ID
- Must vote for each question using the platform. May add an option to abstain.
- Crystal following up with Election Runner regarding
  - Cost
  - Families who share an email
  - Voters who don't have an email.
  - Link
- Hard copies will also be sent out to account for families without email address or technology access
  - Governance Committee will examine for duplicate votes
- Calendar examined. Election results will be submitted to Bethel on June 7, pending board approval on June 22.
- Election date must be announced before April 17th Schoology announcement, website blast, paper flyer sent home with students, auto-call, HA staff email
